TERMS AND CONDITIONS

1. Items for sale may only be sold on the Sunday of the Boat Jumble.
2. All purchases and / or unsold items are to be removed from the site at the end of the show. Rubbish is to be placed in the receptacles provided.
3. For insurance reasons, vehicles **MUST NOT** be parked indiscriminately or moved around the site during the show. Unless they fit your pitch, are to be removed from site by 09.00. The show closes at 15.00
4. No responsibility is accepted by the organiser for security of sale goods or other property before, during or after the show.
5. Exhibitors must have adequate third party insurance and carry out a risk assessment of their activities.
6. Under the explosives act of 1875 it is illegal to sell pyrotechnics from a temporary stand. Therefore pyrotechnics may NOT be offered for sale.
7. The venue is not the property of the organiser and must be treated with due care and respect. Any damage will be the responsibility of the exhibitor.
8. Only Boat Jumble Association Members advertising literature may be distributed at this event.
9. Please ensure that correct documentation is available to admit your vehicle and personnel. Note that security personnel will be on duty and are not authorised to issue tickets or vehicle passes.
